ART MARKET OVERVIEW



In the current climate, many investors are trying to have their savings diversified. As a result, they are investing in tangible, alternative asset classes, especially ones with returns that outperform conventional products provided by high streets.

An asset class cited as top investment (in comparison to others of its kind) is art. Internationally, the artwork economy has consistently grown one year after another. After suffering the worst recession in more than a decade in 2020 due to the strictures bought about by COVID-19, the art market rallied to a nearly unforseeable degree in 2021, achieving a level even higher than that of the year before the pandemic started.

Aggregate Sales by dealers and auctioneers reached \$65.1 Billion, soaring by 29% from 2020, according to the 2022 Art Basel and UBS Global Art Market Report, written by the cultural economists and founder of arts economics, Dr. Clare McAndrew *. (*artbasel.com)

Some have difficulty putting their trust in other people when it comes to investments, particularly when FCA investigations and wrongdoings continuously make headlines. Whether they are experienced or new, one bonus for investors is that by investing in artwork through the Henarch Galleries Art Fund, they will have a completely asset backed investment with full liquidity through the tokenisation of the fund.

Of course, asset class investments aren't anything new. Pension Funds like the British Rail Pension Fund invested £70 million in 1974. Since they invested in art nearly 50 years ago, the fund ended up diversifying its portfolio, hedging against inflation. So it wasn't long before others began investing in art, something investment and fund managers continue to do to this day.

Art is a straightforward investment. One negative aspect of conventional models is how overwhelming they can get. This is especially true of stock markets, where corporate lingo is designed to cause confusion rather than be informative. However art is a tangible investment, and Henarch Galleries Art Fund simplifies the process of helping you obtain it. One great thing about art, is that it is recession-proof. When the market takes a downturn, artwork tends to flourish. A bank cannot spend your artwork, then refuse to repay you.

FUND INVESTMENT STRATEGY



Our investment strategy is focussed on acquiring high-value art assets significantly below market value and tokenising them into fractional ownership units that are tradeable on a secure blockchain platform. By doing so we aim to provide investors with a diversified portfolio of art assets that are easy to buy and sell, with a low barrier to entry.

We have a team of experienced art market professionals who identify and acquire high quality art assets that have the potential to appreciate over the long term. Our investment approach is focussed on maintaining a balanced portfolio of art assets across different styles, periods, and artists.

We will leverage the buying power of the fund to secure significant discounted rates on the artwork from the artists we have selected to work with as well as other sources we have access to, in order to be able to achieve the highest possible sale price in the retail market.

TARGET MARKET



Our target market includes accredited investors who are interested in investing in the art market but may not have market knowledge, expertise or time to source and acquire these high value assets. By tokenising the art assets, we provide investors with a seamless barrier to entry in the art market.

Our fund is also attractive to crypto investors who are looking for alternative investment opportunities that can outperform the banks, offer security and stability and leverage the use of blockchain technology. The use of blockchain technology provides secure and transparent trading of the tokens, and allows far more liquidity when it comes to exiting the market, ensuring there is complete transparency throughout.

The opportunity will be available to investors from all backgrounds worldwide excluding USA, Jordan & Hong Kong.

AQUISITION & SALE



Investors will be able to purchase individual units at a price of \$250 per unit.

There will be a total allocation of 20,000 units available.

With a maximum 2,000 units available at a discounted rate of \$225 per unit through our initial coin offering (ICO).

The investment will be based on an 12 month rolling contract, with written notice required 30 days prior to the end of the investment period or a further 12 months will automatically be applied to the term.

All investors choosing to remain within Smart Fund year two will be rewarded with an additional 2%, bringing your returns target to 20%.

All interest repayments will be reflected quarterly.

Smart Fund optimises the use of the ERC-3643 Token protocol. This open-source suite of smart contracts enables the issuance, management, and transfer of permissioned tokens. This allows token issuers to tokenise any real world asset or financial product, enforce compliance and control their tokens, on any EVM blockchain, even on public blockchains.

THE VISION

Henarch Galleries Art Fund wants to become the leading art asset manager in the tokenised art space. Enabling Crypto investors the chance to purchase tangible assets with their digital currency.

Some of the proceeds of the fund will be utilised to open up a physical gallery in the heart of Dubai where there is growing appetite for the art sector from both collectors and investors alike. This will allow for the artwork owned within the fund to be sold via multiple channels and across multiple continents.



THE RAISE & FUND DATA

Smart Fund's initial raise will be capped at £5Million, with the option of being able to extend this continuously as the fund develops and grows. Anticipating 18% annual returns with a minimum investment of 10 units equating to \$2,500. There will be an initial minimum holding period of 12 months to enable the artwork to grow in value and for the fund to be able to begin trading the various art pieces that have been purchased.

The fund will purchase artwork from the primary market at a minimum of 30% below market value, in turn selling the artwork to collectors via the London Gallery initially, as well as various online portals, through Henarch Galleries Art Advisory, and eventually through the Dubai Gallery which will be opened using some of the proceeds of the fund.
